

1. The Number of Active Cases

Between July 1, 2012 and June 30, 2013, 166 cases were referred to mediation.

2. Status of Cases


During the period, July 1, 2012 to June 30, 2013, mediation was completed in 117 cases. Of these cases 67 (57%) were settled as a result of mediation. This number does not reflect cases that settled after they returned to the court. A total of 49 cases are now pending.





4. Mediation Referral by Cause of Action




5. The Percentage of Settlement through Mediation by Cause of Action



6. Cases






7. Judge Referral Statistics

Fifty-seven (57) percent of all cases referred to mediation in the Eastern District of New York during the past year settled. With the steady increase in civil filings over the past five years, court-annexed mediation offers an effective, efficient and inexpensive means of resolving cases.
