1. The Number of Referred Cases

Between July 1, 2004 and June 30, 2005, 193 cases were referred to mediation. Of the 193 cases, 123 cases were mediated, 65 cases are still pending and 5 cases were withdrawn or dismissed.



July 2004 - June 2005




3. Mediation Referrals by Cause of Action

Cases Referred to Mediation


