

1. The Number of Active Cases

Between July 1, 2011 and June 30, 2012, 153 cases were referred to mediation.

2. Status of Cases


During the period, July 1, 2011 to June 30, 2012, mediation was completed in 95 cases. Of these cases 61 (64%) were settled as a result of mediation. This number does not reflect cases that settled after they returned to the court. A total of 53 cases are now pending.





4. Mediation Referral by Cause of Action




5. The Percentage of Settlement through Mediation by Cause of Action




6. Judge Referral Statistics
