Demographic Tables for New York State Senate Plans

The tables provide demographic data for the following plans of New York State Senate Districts:

1. The Senate districts enacted in 2002, as they stood prior to the enactment of Chap. 16 of the Laws of 2012.
2. The Senate districts enacted by Chap. 16 of the Laws of 2012.
3. The *Senate Alternative (Revised February 12, 2012)*, a 62-district plan submitted to LATFOR on February 15, 2012 by Todd Breitbart.
4. The *63-District Alternative*, adapted by Todd Breitbart on April 23, 2012 from item [3], above.
5. The *Unity Plan Update* (substantially revising an earlier submission) submitted to LATFOR by the Asian-American Legal Defense and Education Fund, the Center for Law and Social Justice at Medgar Evers College, Latino Justice / PRLDEF, and the National Institute for Latino Policy.
6. The Revised 62-District Plan submitted to LATFOR by Common Cause / New York.
7. The Revised 63-District Plan submitted to LATFOR by Common Cause / New York.

For each plan there are four tables:

- A. Total population and deviations from the mean, based on the adjusted database produced by LATFOR in January 2012, which subtracts inmates of state and federal prisons from their places of incarceration, and reallocates the prisoners in state custody to their prior home addresses, pursuant to Chap. 57 of the Laws of 2010.
- B. Voting-Age Population (VAP) from the 2010 Census PL94-171 data set, using the allocation protocol for multiple-race responses prescribed by OMB Bulletin No. 00-02 and *Georgia v. Ashcroft*, FN1 (2003). The ‘AP’ ‘black’ and ‘Asian’ categories include all persons who so identified themselves, with or without another race. There is therefore some overlap between these two categories. All persons who identified themselves as either black or Asian are tabulated first, including both non-Hispanic and Hispanic, and then all persons in the respective categories who identified themselves as non-Hispanic. In this and the following tables, ‘non-Hispanic white’ is a single-race category, and ‘Hispanic’ includes persons of all races.
- C. Voting-Age Population from the 2010 Census PL94-171 data set, using the ‘DOJ’ racial categorization as provided in the *Maptitude for Redistricting* database.
- D. *Citizen Voting-Age Population (CVAP)* from the 2006-2010 American Community Survey (ACS) Special Tabulation. The ‘black_all’ and ‘Asian_all’ categories aggregate the respective single-race categories with all ‘black’ or ‘Asian’ multiple-race categories available from the Special Tabulation.

The tables of voting-age population (listed above as B, C, and D) do not reflect the LATFOR prison-population adjustment. In the counties covered by Sec. 5 of the Voting Rights Act, as in New York City as a whole, lower Westchester, and Long Island, there are few prison facilities from which populations were to be subtracted; but a large number of prisoners were reallocated to these areas from prisons located upstate. Since the reallocated prisoners, all serving sentences for felonies, are ineligible to vote until the expiration of their sentences, they should not be included in a database that is intended to reflect potential voters.
