## IN RE: APPOINTMENT OF A UNITED STATES MAGISTRATE JUDGE MERIT SELECTION PANEL

## ADMINISTRATIVE ORDER NO. 2022-14

Pursuant to the authority conferred by 28 U.S.C. § 631, *et seq.*, and the further authority granted by the Judicial Conference of the United States, the Board of Judges for the Eastern District of New York hereby appoints a Merit Selection Panel to review the applications of candidates for a United States Magistrate Judge vacancy in Brooklyn, New York, for an eight (8)-year term, to be created by the retirement of U.S. Magistrate Judge Roanne L. Mann effective January 5, 2023, and to consider the reappointments of U.S. Magistrate Judge Anne Y. Shields and U.S. Magistrate Judge Peggy Kuo for new eight (8)-year terms.<sup>1</sup> The current term of U.S. Magistrate Judge Anne Y. Shields is due to expire on March 6, 2023. The current term of U.S. Magistrate Judge Peggy Kuo is due to expire on October 9, 2023.

It is further ORDERED that within ninety (90) days of appointment, the Panel must provide the Court with a recommendation of five (5) applicants to interview for the current vacancy. It is further ORDERED that within ninety (90) days of appointment, the Panel must provide the Court with the Panel's recommendation regarding the reappointments of incumbents U.S. Magistrate Judge Anne Y. Shields and U.S. Magistrate Judge Peggy Kuo.

All applications for the magistrate judge vacancy must be received by August 15, 2022 and all public comments on the reappointments must be received by August 15, 2022.
